Description and Location of Proposed Activity:

This proposed project involves buffer encroachments necessary to construct a data center and associated infrastructure north and west at the intersection of Sigman Road and Farmer Road and south of Lester Road in Rockdale County. The project will require 39.18 acres of disturbance including permanent impacts (pipe/fill) to 1,136 total linear feet (24,478 total square feet) of buffer along an unnamed tributary to Shipley Branch in the Upper Ocmulgee Watershed (03070103).
